

We want to welcome you to Action Inc.

We hope you are asking yourself, "Why would I want to work for Action, Inc., and join the Plumbing Apprenticeship Program and how does the program work?"

#### First, a little bit of history about Action, Inc:

Action is one of the largest Mechanical Contractors in Arkansas and surrounding regions. It was founded in 1981 and has been in the Mechanical Contracting business since. We have four locations: Our home office is in Barling and our surrounding offices are located in Maumelle, Jonesboro, and Tulsa, OK

#### So how does the Apprentice Program work:

- >>> The Apprenticeship Program is a 4-year program. Successful candidates will be hired as a full-time employee, work for us during the day and attend school in the evening, either 1 or 2 nights per week, depending on the school.
- >>> The schools are structured much like high school. Each year has 2 semesters; fall thru December and January thru April.
- >>> You can earn a total of 80 hours per semester, with a total of 160 per year. (Make-up time is available).
- >>> After completing 4 years you would have accumulated the 640 hours needed to test for Journeyman Plumber license. This license is issued thru the Department of Health, from the State of Arkansas.

# RECRUITING BONUS FOR NEW APPRENTICE PLUMBERS ARKANSAS AND EAST OKLAHOMA REGIONS

#### Effective May 1, 2018

Any Apprentice hired on May 1, 2018 or after, will be included in this program. If you have already been attending apprentice school for your JP prior to coming to Action, the below criteria will be based on years worked here. Completion of 2 years, Completion of 4 years, and Completion of 5 years employment. You will have had to advance to a Journeyman Position by the end of the 4<sup>th</sup> year of employment.

**Recruiting Bonuses for New Apprentice Plumbers.** 

As a new hire, you will be eligible for a \$5000.00-tiered bonus:

- \$1500.00 bonus at the successful completion of the second year of the Apprenticeship Program. The Apprentice cannot be absent or tardy more than 3 times in any semester at the apprentice school, thru the end of the 2<sup>nd</sup> year to receive this bonus. The Apprentice must meet the mandatory Arkansas-regulated On-the-Job training hours of 1000 hours each semester, or what is current for that semester.
- \$1500.00 bonus at the completion of the apprenticeship program and successfully test to a JP. The Apprentice cannot be absent or tardy more than 3 times in any semester at the apprentice school, during 3<sup>rd</sup> and 4<sup>th</sup> year to receive this bonus. The Apprentice must meet the mandatory Arkansas-regulated On-the-Job training hours of 1000 hours each semester, or what is current for that semester.
- \$2000.00 bonus one year after successful test.

Additional Criteria: No written warnings or greater, allowed throughout the 5-year recruiting program.

Must have a "score of 3.5 or above" on all annual evaluations.





# PLUMBING APPRENTICESHIP TRAINING

BUILDING MINDS. BUILDING SKILLS. BUILDING FUTURES.

ACTA is the official school affiliated with the Associated Builders & Contractors of Arkansas. It provides a formal apprenticeship training program that is registered with the United States Department of Labor, Office of Apprenticeship (OA). This program meets all federal and state requirements for formal classroom instruction. Apprenticeship training combines work and academics in a formal program leading to journeyperson consideration.

The student must be 18 years of age, physically capable of performing required tasks, working for an employer, able to collect OJT time, and registered through their employer with the Department of Labor, Office of Apprenticeship (OA). The majority of the crafts require 8,000 hours of on-the-job supervised training (approximately four years for full time work). Plumbing apprentices are also required to complete 640 hours of classroom training (approximately four years). Upon successful completion, craft workers are recognized at the journey-level in their trade and are awarded their BAT certificate.
